

Congress and Clinton Destroyed America

My name is Anthony J. Windisch. I am a Certified Computing Professional, and a federal Whistleblower.

I claim, **"OUR UNITED STATES CONGRESS IS 'OUT OF CONTROL', AND ALONG WITH PRESIDENTS BILL CLINTON AND BARACK OBAMA, HAVE ACTED AND/OR NOT ACTED TO CAUSE THE DESTRUCTION OF AMERICA!"**

During the last 30 years the General Accountability Office (GAO) which is the congressional "WATCHDOG", has issued dozens of reports that are critical about the operation of most federal agencies. And while Congress continues to ignore these critical GAO reports, GAO has 'NO TEETH' to enforce its recommendations. Showing how Congress is **OUT OF CONTROL**.

Beginning in 1982. I worked almost ten years for the federal government. I found that federal system ACCOUNTANTS have the job to '...implement 'State of the Art' computer systems...'

After working through three major computer system projects that failed, I filed a Whistleblower Complaint about Computer Mismanagement throughout the federal government.

In 1991, my attorney wrote to the General Accountability Office (GAO), who issued report GAO/IMTEC-99-9. Report cover page explains, 'ADP MODERNIZATION - Half-Billion Dollar FmHA effort lacks Adequate Planning and Oversight ...', which verified my COMPLAINT. But Congress did not investigate and has taken NO corrective action.

I filed a Whistleblower Complaint with the 'Office of Special Counsel' (OSC) under the 1989 Whistleblower Protection Act. There was no personal contact with me by the Office of Special Counsel (OSC), my Whistleblower Complaint was not adequately investigated, and my Complaint was rejected by the 'Office of Special Counsel' (OSC).

In 1993, after four years of OSC history, the General Accountability Office (GAO) issued report GAO/GGD-94-21. 'WHISTLEBLOWER PROTECTION - Reasons for Whistleblower Complainants' Dissatisfaction Need To Be Explored...'

In 1992, I received report GAO/OCG-93-4TR titled 'FINANCIAL MANAGEMENT ISSUES'. The opening statement warns, 'Widespread financial management weaknesses are crippling the ability of our leaders to effectively run the federal government...'

CONGRESS CONTINUES TO IGNORE 'FINANCIAL MANAGEMENT ISSUES' AND MANY OTHER GAO REPORTS.

Congress and President Bill Clinton ignored the many CRITICAL recommendations in GAO's "Financial Management Issues" report. And they implemented the one bad suggestion on page 29. "...The government could also benefit from more cross-servicing, in which one agency provides payroll services to another agency. Today, for instance, the Department of Agriculture provides payroll services to about 40 other agencies...".

In response, the US Treasury Department farmed its 'Financial Management Service' (FMS), which provides computer financial services for most federal agencies.

In 2002, GAO issued report GA0-02- 317. Headline, 'FINANCIAL MANAGEMENT SERVICE Significant Weaknesses in Computer Controls Continue...'. AND CONGRESS IGNORES THIS REPORT.

FMS has destroyed the main function of the Federal Reserve System (FRS), which is our nation's bank. As our national bank the FRS is supposed to process ALL NATIONAL FINANCIAL TRANSACTIONS, which are needed and used to balance individual agency 'Financial Statements'. Today, agency 'Financial Statements' ARE NOT AND CANNOT BE BALANCED. And alarmingly, 'Nobody can know how many employee 'PAYROLL TAX DEDUCTIONS' are **NOT SENT** to the Internal Revenue Service (IRS).

To make matters worse, Congress and Clinton worked to eliminate Banking Controls. The WALL STREET JOURNAL has published many stories about how our 'Big Banks' are declared CRIMINAL in foreign countries. And today, OUR Federal Reserve System (FRS) operates to serve these same CRIMINAL 'Big Banks' by keeping 'Low Interest Rates'. And these 'Low Interest Rates' continue to steal from every American's SAVING ACCOUNTS, from every American's RETIREMENT PLANS, and from every American's ANNUITY PROGRAMS.

MEMBERS OF CONGRESS CONTINUE TO IGNORE WARNINGS FROM THEIR GENERAL ACCOUNTABILITY OFFICE, WARNINGS FROM THE PUBLIC NEWS MEDIA, AND WARNINGS FROM WHISTLEBLOWERS LIKE MYSELF.

On my first job in government, I discovered that 'FINANCIAL CONTROL TOTALS' were missing from the computer disc file containing 50 billion dollars in farm loans. AND NOBODY WOULD LISTEN TO MY COMPLAINT!

In 1989, I objected to the, USDA purchase of Oracle computers, because oracle uses the Internet for communications. AND THE "INTERNET" IS KNOWN TO BE A PLAYGROUND FOR COMPUTER HACKERS. And without "FINANCIAL CONTROL TOTALS" NOBODY CAN KNOW IF NOR WHEN 'COMPUTER HACKERS' HAVE INVADED.

In 2000, in response to the worldwide LOVEBUG invasion of computers, GAO issued report GAO 0/T-AIMD-00-181. On page 12, "...FURTHER ACTIONS REQUIRED... the potential for more catastrophic damage is significant. Official estimates show that over 100 countries already have or are developing computer attack capabilities. Hostile nations or terrorists could use cyber-based tools and techniques to disrupt military operations, communication networks, and other information systems or networks...'"

And on Page 13, "'... Federal agencies are not only at risk from computer virus attacks, but are also at serious risk of having their key systems and information assets compromised or damaged from both computer hackers as well as unauthorized insiders...'"

I received an October 24, 2012 letter from an Associate General Counsel at GAO. "'...GAO makes recommendations to agencies that are intended to improve the economy, efficiency and effectiveness of agency operations. However, GAO does not have legal authority to sue to enforce its recommendations...'"

On February 25, 2015, I wrote to President Barack Obama. "'...YOU HAVE NOT ANSWERED MY PREVIOUS LETTERS!...'", Nor my FINAL report which I have also mailed to the General Accountability Office (GAO).

President Barack Obama answered on August 13, 2015. "'Thank you for writng. Messages like yours serve as an important reminder of the work that still lies ahead, and they reflect a commitment to staying engaged in shaping the future we know is possible. As long as I'm President, I'll keep pouring everything I have into securing a brighter tomorrow for people across our country. Again, thank you for writing. By embracing hope and speaking out on issues that matter to you, you can help make a difference. I want you to know I'm listening, and I wish you all the best. Sincerely, (signed Barack Obama)
